A Note from the President

At a recent Board meeting, I was again reminded about the importance of accurate communication. If all members had been contacted and had an opportunity to provide their input, it would have saved about half an hour at the meeting. As President of Audubon Chapter of Minneapolis, I vow to minimize the effects of poor communications. As an organization whose objective is to educate our members and the general public about the natural environment and birds in particular, it is important to get our message to you! We have two primary outlets for this—the Kingfisher and our website.

The Kingfisher is our longer term outlet for the information we want to communicate to you. Because of the time it takes to put together the Kingfisher, it is very difficult to get information into it that is less than a month old. We have a 1st of the month deadline for submitting articles, which gives the editor about 10–14 days to assemble it, gives the printer about 5 days to print it, and the mailing team 3 days to get it to the post office. You usually receive the Kingfisher on about Thursday after the 3rd Monday of the month. That gives you only about 10 days to read about what's happening at the upcoming program.

The time it takes to get something published in print is why we also maintain a website. Our website, www.geocities.com/audubon.geo, is our quick action communications tool. Information can be available to our members and the general public in less than 2 days, depending upon the availability of our webmaster. It also acts as a backup for the Kingfisher by providing access to the current Kingfisher and the past issues on the website, and it provides other vital information that just can't be printed in the Kingfisher each month. An example is the volunteer opportunities at Audubon Chapter of Minneapolis (I had to get one pitch in for help) new section. Please check the website often!

Finally we have quick communications through e-mail. While we don't have everyone's address, we do have over a hundred of you in our database. We've had this for about 6 months now. Fortunately, we have not had to use it yet. I think we have shown we are responsible in not using it unless needed, and I would encourage you to share your e-mail address with us so that if we need to, we can contact you quickly. Just send me a message stating you want to be added to our database (see page 2 for my e-mail address).

October Program

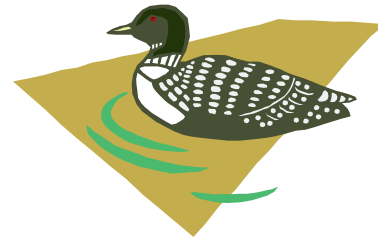
Lead and Loons

Pam Perry comes to us from Brainerd where she has been a Regional Nongame Specialist for the past 22 years. Because of her interest in loons, Pam has been following the loon research regarding lead poisoning from the ingestion of fishing tackle. An approximate 24% mortality rate has been recorded in studies of adult loons during the breeding season in New England, Michigan some Canadian provinces. Limited research in Minnesota has shown that some loons are dying from lead poisoning, but the full extent is not yet known.

As a Nongame Specialist, Pam works with many different nongame and endangered wildlife species and has a special interest in loons, eagles, red-shouldered hawks, osprey, Blanding's turtles, landscaping for wildlife, and protecting lakeshores. She also coordinates the statewide Volunteer Loon Watcher Survey and in 2004 coordinated the first statewide survey of nesting osprey.

She received a Bachelor of Science degree from the University of Minnesota in wildlife management and a Master of Science degree from the University of Florida in wildlife ecology. Come join us.

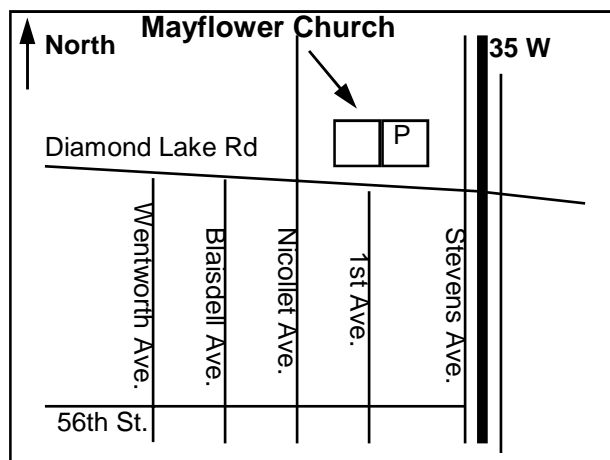

Important Bird Areas (IBA's)

National Audubon Society is focusing on helping preserve natural areas through the international Important Bird Areas (IBA's) initiative. Mark Martell, the Interim Executive Director and IBA Director of Audubon Minnesota, gave a presentation last spring on the importance of IBA's internationally. Minnesota is just getting started in identifying IBA's in the state.

Mark put out a call for IBA site nominations at that meeting. Jerry and Donna Bahls have begun the process of nominating sites within the Audubon Chapter of Minneapolis area. They have found that the nomination process is very extensive. They would like to have help in nominating all the areas that have been tentatively identified as IBA's in our area.

Flying in Fog, 419 Birds Hit Wire and Die

One of the worst bird kills in years happened this week [week of 5/28/04] when at least 419 songbirds died after they struck support wires at a tower in northern Anoka County, a state wildlife biologist said.

More than 30 species of night-migrating songbirds, predominantly Tennessee and yellow warblers, were collected late Tuesday and Wednesday from beneath the wires at the tower, just south of St. Francis in Burns Township.

Bob Fashingbauer, assistant wildlife area manager at the nearby Carlos Avery Wildlife Management Area, said he believes that the birds, which were migrating north, became confused by the tower's light beacon during a recent foggy evening. The light, he said, attracted the birds, which then flew around it, periodically striking guy wires supporting the tower.

2004 Issue Nomination Form and Fall Membership Meeting Registration



The Process

Audubon's process for selecting the state legislative priority list begins by soliciting nominations of issues from Audubon members. The issue nomination process ends on Friday, September 30th - your nominations are due in our office on that day. After this, the nominated issues will be consolidated and written-up as a ballot. Ballots often contain anywhere from 10 to 20 issue descriptions. On the ballot members will rank their top five issues - we will mail the ballot out to you and you can pick up copies at your chapter meetings, too. The top five issues will be discussed at the annual Fall Members meeting.

Members attending the meeting will debate and prioritize three of the five issues and those three issues will become Audubon's legislative agenda for the 2005 state legislative session. All Audubon members in Minnesota are eligible to nominate and participate in the selection of the issues.

September chapter meetings should include time to discuss ballot issues and hand out ballot forms. During the election season, please use the ballots as tools to educate candidates in your district and to formulate debate questions. In order to adhere to federal law for nonprofit 501(c3), your chapter must provide all candidates in an electoral race with the same information—if you share information with one candidate, you must then provide it to all.

If you've had a policy issue on your mind, don't assume someone else will be smart enough to nominate it. Do it yourself. On the flip-side of this mailing is the issue nomination form and the registration form for our Fall Members meeting. *Remember!* - You **DO NOT** need to attend the Fall meeting in order to nominate an issue, nor do you need to nominate an issue to attend the Fall meeting. If you want to nominate an issue now, and register for the meeting later - that's fine.

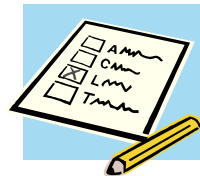
The Fall Members Meeting

Buckthorn Wars—Year II

Last year we learned what buckthorn was, what it looked like, why it's a problem and how to get rid of it. Buckthorn Wars -Year II we'll attack, seeking to cut this insidious invader at the roots. We will do reconnaissance to locate the mother (female) trees in the public arena and mark them with a blue marker for later destruction by the local militias (government officials). First we will need to gain the allegiance of these local militias by meeting with their representatives and receive permission to enter their territory armed with our blue marking devices. Then we'll convince them to cut out the buckthorn at the roots!

Thank you very much for selecting me and paying for the scholarship to attend the Hunt Hill Audubon Sanctuary's Adult Camp program "Wade into Ecology" July 4 – 9. I had an informative and good time with four other participants even though the weather was colder and wetter than normal.

The three instructors were excellent in helping us to identify birds, trees and plants. We found a nest with two baby birds and one egg on our walk. I got wet up to my knees in water when we went bog walking to find pitcher and sundew plants.

What interested me the most was the measurement and

chemical testing on the lake study and the analysis of the data afterward. On the canoe trip down the Namekagon River we chased eagles down river and tried to avoid hitting rocks.

The food was great with a game hen for one meal and a fish boil for another meal. The last session was on Wild Edibles.
